

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to mylappetbed.pet and Innovational Pet Products LLC., NJ and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Innovational Pet Products LLC., NJ include mylappetbed.pet and Innovational Pet Products LLC. Collection of your Personal Information
